VSCA Privacy Policy



1. INTENT

VSCA takes the privacy of all its league participants very seriously. The intent of the VSCA Privacy Policy is to explain what personal data VSCA collects and requires of its members and competitors, why VSCA collects this data and how it uses this data.

By registering to become a VSCA member via the VSCA website, all members confirm they have read and accepted this privacy policy in full.

VSCA is asking for personal data from its members, because the league strives for professional-grade and comprehensive coverage of its Events, Drivers and Teams on VSCAracing.com, Broadcasts/Live Streams and Social Media, much like racing series and Drivers/Teams do in real-life.

The goal is to promote VSCA, its Events, Drivers and Teams through high-quality content and journalism.

The idea behind this is also to maximize exposure of VSCA, its Events, Drivers and Teams to make them relatable and interesting to readers, viewers and fans and to make VSCA, its Events, Drivers and Teams more attractive to existing and future Investors, Sponsors and Partners.

2. THIRD PARTIES

All personal information gathered will exclusively be used within VSCA and for the purpose stated in this Privacy Policy. Personal data, regardless of what scope or type, will never be sold by VSCA to third parties.

Profile information of Competitors that is made accessible to the public on the VSCA website may be shared with third parties, exclusively for the purpose to be used within VSCA events.

Example: In the case that VSCA races are broadcast live by a third party broadcast provider (Apex Racing TV, etc.), VSCA may share the public information of Competitors's VSCA profile with that broadcast provider, for stream overlays and as a resource for live broadcast commentary.
